I understand that I am responsible for payment of the contracted fees, due on the 15th of each month (July and September-April).

Refund requests for withdrawal from the program must be received by Butterfield Park District prior to August 1st in order to receive a tuition refund. The \$100 administrative fee is non-refundable and is due at the time of enrollment. The administrative fee will be processed after May 1st, 2022. I agree to pay the amount that corresponds to my child's class as listed.

The program will assume full responsibility for my child from the time my child arrives at the program location until the end of class upon pick-up.

If a medical emergency arises the program staff will first attempt to contact me. If I cannot be reached, the staff will follow the procedure preferences I have indicated. If emergency attention is needed, the staff will call an ambulance with all expenses being my sole responsibility.

Rates are subject to change from school year to school year.
