Approval of Ordinance #22-11-1: An Ordinance providing for the issue of \$288,123 General Obligation Limited Tax Park Bonds, Series 2022, of the Butterfield Park District, DuPage County, Illinois, for the payment of land for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of said Park District and for the payment of the expenses incident thereto, and to provide the revenue source for the payment of certain outstanding bonds of the District, providing for the levy of a direct annual tax to pay the principal and interest on said bonds, and authorizing the sale of said bonds to Republic Bank of Chicago.
